SUMMER TENNIS MEMBERSHIP ADDENDUM

I/We wish to become a Summer Tennis Member of Canyon Creek Country Club based upon the following terms and conditions:

1. **Summer Tennis Membership.** I/We understand for a period beginning on the date of acceptance set forth on May 1st, and continuing for four (4) consecutive months (the "Summer Tennis Membership Period"), as a Summer Tennis Member, I/we will be entitled to full access to all social privileges, access to outdoor and indoor tennis courts, member pricing on all tennis programs and access to the swim facilities. I/We agree to be responsible for the payment of all food and beverage charges, service charges, and applicable sales tax incurred in the use of the Summer Tennis Membership. Summer Tennis Memberships are nontransferable and may not be assigned.

2. **Monthly Dues.** I/We understand that my/our monthly dues during the Summer Tennis Membership Period will be waived.

3. **Membership Fees.** I/We understand that upon acceptance as a Summer Tennis Member, I/we will be responsible for the payment of a nonrefundable Membership Fee in the amount of \$676.56 (tax included).

4. **Expiration of Summer Membership.** Upon expiration of my/our Summer Tennis Membership, I/we understand I/we will no longer have membership privileges at the Club unless I/we elect to continue membership in the Club.
