Player Development Plan Privileges

Upon execution of this Player Development Plan Agreement ("Agreement") and payment of the Prepaid Player Fee set forth herein, Primary Player and his/her spouse (collectively, "Player") and authorized dependents set forth above will each receive a range pass allowing access to the Player Privileges defined herein.

Club and Player agree and acknowledge that Player and authorized dependents, as applicable, set forth above may enjoy the following privileges at the Club during the applicable term described below and subject to the terms and conditions stated herein (the "Player Privileges"):

- Range and practice facility usage at the Club's range facilities during regular operating hours, subject to availability and at the Club's discretion.
- Group clinics as scheduled by the Club from time to time at the range facilities. Participation in clinics is subject to availability and clinics may be cancelled by the Club in its sole discretion.
- One (1) complimentary round of golf per month per individual, which must be used between Monday and Thursday or Sunday after 12:00 p.m. Player may reserve such round up to seven (7) days in advance. Any unused rounds will be automatically forfeited upon the expiration of the calendar month in which issued. Such rounds are non-transferable, may not be redeemed for cash and may not be relocated to any affiliate club.
- Access to the golf course during Twilight hours, if booked the same day, in exchange for a \$49.00* pay-per-use green fee. Valid for Player and up to three (3) guests.
- Access to the golf course during Sunset hours in exchange for a \$30.00* pay-per-use green fee or a \$20.00 pay-per-use green fee for under 18's.

The Player Privileges are personal to Player and authorized spouse and dependents, as applicable, and do not include access for Player's guests, unauthorized spouse or dependents, who must pay the applicable fees in order to access the Club's facilities.
*Applicable sales tax, if any, not included. Pay-per-use green fees are subject customary increases.

PLAYER FEE AND TERM (select one option only)

Primary Player Development Plans: (only Primary Player may enjoy Player Privileges)

- I agree to pay a monthly non-refundable Prepaid Player Fee of **\$84.00*** per month for a period of twelve (**12**) consecutive months commencing upon the date this Agreement is accepted by the Club in exchange for Player Privileges during such term.
- I agree to pay a monthly non-refundable Prepaid Player Fee of **\$99.00*** per month for a period of four (**4**) consecutive months commencing upon the date this Agreement is accepted by the Club in exchange for Player Privileges during such term.
- I agree to pay a monthly non-refundable Prepaid Player Fee of **\$144.00*** per month for a period of one (**1**) month commencing upon the date this Agreement is accepted by the Club in exchange for Player Privileges during such term.

Additional Family Offering:

- I agree to pay an additional monthly non-refundable Prepaid Player Fee of **\$44.00*** per month for **each** spouse and/or authorized dependents added to my Development Plan for a period of twelve (**12**) consecutive months commencing upon the date this Agreement is accepted by the Club in exchange for such spouse or authorized dependents Player Privileges during such term.

Upon expiration of the applicable term, this Agreement and all associated Player Privileges will continue on a month-to-month basis unless Player and Club agree otherwise in writing. Player understands and agrees that regardless of Player's use of the Club's facilities and amenities, Player Fees are nonrefundable, do not have any stored or cash value, and may not be transferred or relocated to any affiliate club.

*Applicable sales tax, if any, not included. Player Fees are subject to customary increases and late fee/collection penalties.
