



## ALTA and USTA Adult Team Tennis

Updated 9-17-2019

### FAQ-Captains

First, we would like to thank-you for being a captain. We understand how important you are to the success of your team and the communication with the Tennis Center. We have designed a document to assist in your execution of your team for the season.

#### Section 1

- All ALTA and USTA team rosters must be submitted to and approved by the Tennis Center's GM no later than **2 weeks prior** to registration closing for the respective season. We accommodate teams on a first come first serve basis and cannot guarantee we can accommodate all interested teams. We are at capacity and teams that do not gain approval by the tennis center may not have home courts. All fees must be paid with submission of roster. Approval of teams:
  - **Teams with highest % of PTC Residents first**
  - **Teams with highest % pass holder next**
  - **We require 1 payment for coaching fees and 1 payment for team fees from the captain.**

**We will be hosting 14 teams on any given match day. Do not delay in submitting your roster and it is imperative you receive approval from the facility before you register your team with ALTA and USTA by emailing [jonathan.fralick@clubcorp.com](mailto:jonathan.fralick@clubcorp.com)**

- Teams must designate their court preference if they are a hard court team, clay court team, or no preference. We will **try to accommodate** all teams but surfaces may be switched based on the availability of the tennis center. In the winter, clay court teams, if courts are frozen, **will not be guaranteed** movement to hard courts. It will depend on availability of the courts. Matches

may be moved to an indoor court per our discretion. Captains must communicate in advance with our Front Desk Manager and/or GM.

- **ALTA Teams** that utilize 2 court coaching (9 players or greater) will be given a **third** court for their match. The surface of this court is not guaranteed, but we will try to accommodate the same surface in all cases possible. We will give each team a 2 week notification if the surface must be changed due to availability of the courts.
- **All players that are not pass holders and on a roster will pay the team fee for their respective team. Full Time Certified Teaching Professionals are exempt from team fees as a professional courtesy at the Double a 1 & 2 level only. Players need to communicate with the General Manager in advance. Team fees cover 8 weeks.**
- **Due to the ever changing USTA schedule, if a season is scheduled past 8 weeks an additional \$10 per week will be added to individual team fee. Teams that would like to have additional practices will be at a rate of \$10 per week per non-pass holder. Pass holders are free.**
- **If a player is discovered not to have paid as policy dictates, the captain will be charged \$100 per infraction.**
- **Players outside a 60 mile radius are exempt from team fees, but are required to pay a \$15 per home match fee.**

### **Coaching or Practice Courts:**

- In order to receive Team Rates, Teams must play home matches out of the Tennis Center. Team Drills are defined as 6 players or greater taking coaching. We will bill pass holder accounts but non-player pass holders must pay the captain and the captain will pay Tennis Center.
- All Teams coaching out of the Tennis Center will have a max **6-1 ratio** as communicated by the captain to the lead coach of the team. The lead coach and captain will communicate the amount of players and the coaches scheduled for the team. We will try to accommodate all requests but there are times we cannot. **Players may not sub for each other.**
- All ALTA/USTA seasons are defined as 8 weeks. If an organizing body schedule greater than 8 weeks we will charge each player that is not a pass holder \$10 per week in excess of 8 weeks. Payment for practices, for the whole team must be paid in full prior to the first day of practice. We will **refund unused practice fees** if weather causes practices to be cancelled and we are not able to offer the set amount of days. Teams are expected to go indoors. **We will run a package**

of drills for 6 drills that can be used in 8 weeks. We adjust staffing to reflect a 6-1 ratio. If 4 players show up and 7-12 confirmed you will have 1 coach. This allows us to add the extra drills.

- In case of inclement weather the lead coach will **communicate with the captain** about practice cancellation. **Please do not call the front desk.**
- **ALTA Teams** that utilize 2 court coaching (9 players or greater) will be given a third court for their match. This **does not apply to USTA** as we have too many teams and too many other activities at the club during these seasons.

USTA and ALTA Team Captains are the lifeblood of team tennis. **For teams coaching and playing matches out of the tennis center, we would like, in our appreciation of you, deduct \$50 off of your coaching package.** Please designate on your roster who is the captain. We are completely committed to our **pass holder** and their guests and all of our fees, coaching, and communication will be transparent and professional in nature. Please see the GM if any experience at the club does not exceed your expectation.

#### Team Package Drills (8-9 week minimum)

\$15 per hour player pass holder \$20 per hour non-player pass holder for a drill package

\$22.50 per 90 minutes pass holder \$30 per 90 minutes non-player pass holder for a drill package

Players are purchasing 6 drills to be used in 8 weeks, if exceed 6 rate is same as drill package rate

### Team Player Drop-In Drill

\$20 per hour pass holder \$25 per hour non- pass holder for a drill package

\$30 per 90 minutes pass holder \$37.50 per 90 minutes non- pass holder for a drill package

## **Team Fee Explained**

The Peachtree City Tennis Center prides itself on being a full service tennis facility for our community and our guests into our community. Teams are a vital piece of the Tennis Center and we would like to explain how individual team fees are calculated.

- **A typical team season is 8-10 weeks (basically 2 months). Each team is scheduled on average 4 home matches per season.**
  - Home matches utilize 2 courts for about 5 hours per court (10 total)
  - Going rate is \$20 per hour per court for doubles
  - Each Home match has court fees of \$200
  - Multiply by 4 matches and we have \$800
  
- **Each team is offered 2 courts for 1.5 hours per week for practice**
  - 3 hours of court time per week at \$20 per hour
  - Each practice is \$60
  - 8 weeks of practice is \$480
  
- **The Gross total for court fees for an 8 week season is \$1280 per team per season**
  - The amount of players per roster usually are about 12-14 players and we total amount of players into the gross court fee.
  - The range per player amounts to about \$80-\$90
  
- **A Team Fee for an individual per team is \$60/\$66 Individual and Senior \$50/\$55**
  
- **As we build towards the future we have to make sure we have courts available for our community and we feel it is vital for transparency across all of our programs in regards to pricing to be fair and up front.**
