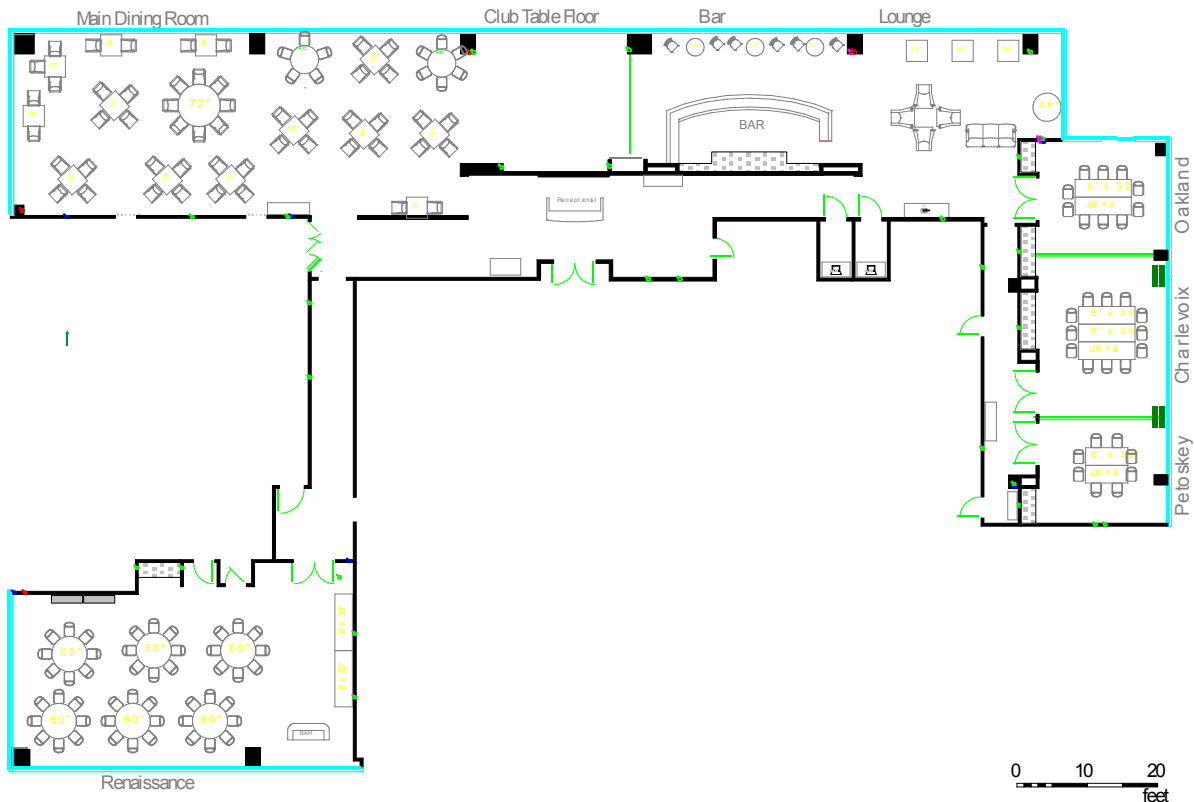

# POLICIES & PROCEDURES

## FOOD & BEVERAGE MINIMUMS

All events are required to meet a food and beverage minimum. A food and beverage minimum is the amount a host must spend in order to secure a private space at the Club. If the minimum is not met, the difference will be charged as a minimum fee. For example, if the minimum is \$5,000 and you have 100 guests in attendance, you have a minimum of \$50 per person to spend in your menu and bar selection. Please note your actual event cost may exceed your food & beverage minimum based on final menu selection(s) and guest count.

## FOOD, BEVERAGE , & BAR SERVICES

Skyline Club must provide all food and beverage. No outside food and beverages are allowed with the exception of wedding and specialty cakes. Due to health regulations, perishable leftovers may not be removed from the property. Skyline Club reserves the right to request identification from any guest appearing to be under the age of 40, failure to provide identification will result in refusal of service. Skyline Club reserves the right to refuse service to any guest that appears to be intoxicated or under the influence of any substance. Shots will not be served from the bar at anytime during an event.

## NON-MEMBER FACILITY FEES

Non-members are welcome to host events at the Club, however a facility fee will apply in order to access the Club. Facility fees ensure private access to club amenities and private rooms.

## DRESS CODE

It is the responsibility of the event host to communicate Club dress code to all attendees of their event. Any person(s) not compliant with the dress code may be refused entry to the Club. Dress code requires business casual attire to be worn. Denim is prohibited in the Southfield Dining Room. Athletic wear, rubber soled shoes, and scrubs of any kind are not permitted anywhere in the Club.

## TAXES & SERVICE CHARGE

State of Michigan sales tax will be added to all private events charges at a rate of 6%. Events that qualify for tax exemption status must return a complete copy of State of Michigan Form 3372 to the Club prior to the event in order to have tax be non-applicable to charges. Service Charge is applied to all food & beverage charges at a rate of 22%.

## GAURANTEES

Your guaranteed number of guests is due to the private event director seven (7) days prior to the event. In the event the Club does not receive a guarantee, the number of guests previously indicated on your signed contract will serve as the guarantee. Actual charges will depend on the guarantee given or the actual attendance at the event whichever is greater. If the number in attendance exceeds your guarantee given, the club can prepare additional meals. The host will be charged a higher rate for each additional guest: the same meal cannot always be promised should your attendance be greater than your guarantee.
